IMPLEMENTING PARTNER WORLD VISION TO DRILL BOREHOLES, REHABILITATED WATER POINTS, FORM WATER
COMMITTEES, AND WE TRAINED COMMUNITY MEMBERS IN PUMP MAINTENANCE AND REPAIRS. WE INCREASED ACCESS

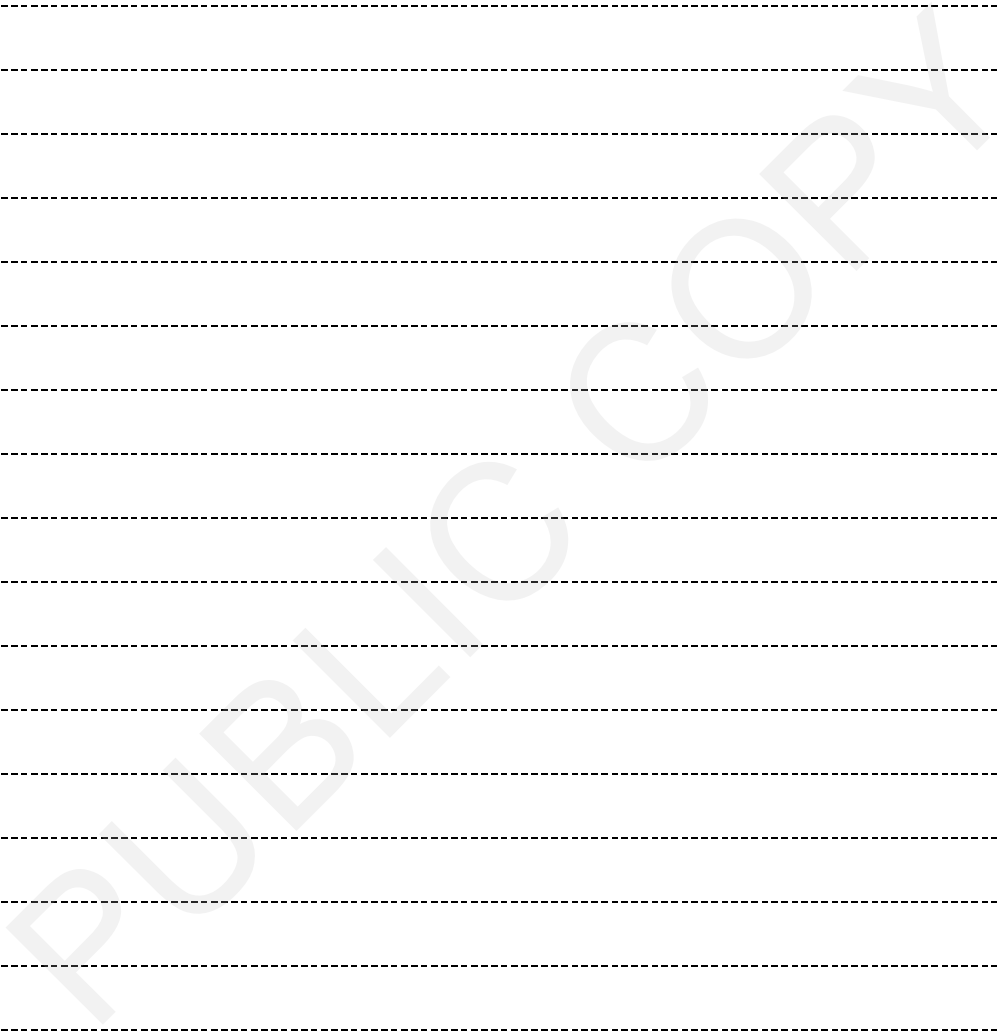
